Thanks to the generosity of our donors, the Community Foundation of Southeast Kansas (CFSEK) experienced another year of tremendous asset and grant making growth during 2006. Donations to the Foundation exceeded \$2.7 million with total assets ending the year at \$4.8 million, a 26% increase over the previous year. Additionally, the CFSEK granted over \$1.7 million for projects and programs supported by our many donors. With this growth comes an increased responsibility to be good stewards of the resources entrusted to our care. This is a responsibility that our board and staff take most seriously.

The CFSEK was very pleased to complete the Kansas Health Foundation Phase 4 Challenge in 2006. By raising \$700,000 in endowed funds, the CFSEK qualified for an additional \$700,000 for our KHF Children's Endowment Fund. Funds from this endowment are used to support a portion of the grant making activities of the CFSEK. A listing of the grants made in 2006 is included in this report. Also, because of the successful completion of this Challenge, the CFSEK was invited to participate in the Phase V Challenge which could earn an additional \$350,000 for the Children's Fund.

Nutrition and Physical Activity Project Update:

In the fall of 2006, CFSEK received a 3 year-\$300,000 grant from the Kansas Health Foundation to improve nutrition and physical activity awareness in the southeast Kansas area. Local awareness efforts are combined with the state-wide public motivation campaign, change something®, that was launched by KHF in September of 2006. According to Marni Vliet, president & CEO of KHF, "The 'change something' campaign serves as a reminder that opportunities exist all around us to be more physically active and incorporate healthier eating habits. Simple, daily changes add up to healthier lifestyles and improve the health outlook for Kansans." The Community Foundation is introducing the project into Crawford County for the first year, and will be moving into Bourbon, Cherokee, and Labette counties in the fall of 2007.

To begin the NPA project, the Community Foundation organized the Crawford County Listening Tour and visited area organizations to talk to members about their views on health and wellness and how the community can best support their efforts to live healthy and active lives. On the listening tour, CFSEK was in front of 15 groups and nearly 500 participants of all ages. Three emergent themes were identified on the tour to focus the efforts of CFSEK: Families, Schools, and the Community.

The next step in the NPA project was to help convene a Health and Wellness Committee. CFSEK has partnered with the Crawford County Community Coalition to create this committee. The Health and Wellness committee is working to create a strategic wellness plan for Crawford County, with the Vision of Crawford County: Healthy and Active for Life! Community Foundation of Southeast Kansas Completes Phase 4 Challenge

The Community Foundation of Southeast Kansas celebrated the holiday season early in 2006. The Kansas Health Foundation challenge of raising \$700,000 endowed dollars by the end of 2006 was completed in late October. According to Chris Ward, "The Kansas Health Foundation has been instrumental to the success of our foundation

By completing this challenge, Kansas Health Foundation has agreed to match, dollar for dollar, the \$700,000 raised locally. The KHF challenge dollars will be placed in the KHF Endowed Children's Fund which we administer. Grants from this fund are made to local agencies each fall," explained Ward.

Trustees were quick to point out that the success of meeting this challenge reflects positively on donors in Southeast Kansas. Agencies and individual donors that contributed to CFSEK endowments believe in the future of southeast Kansas. Endowment funds invest the principal and use the returns on investments to make charitable grants.

CFSEK has participated in the Kansas Health Foundation GROW initiatives since 2001. The GROW (Giving Resources to Our World) Healthy Kansas Initiative is a partnership between the Kansas Health Foundation and a select group of community foundations throughout the state of Kansas. The Kansas Health Foundation believes that Kansas community foundations build and strengthen their communities.

The group noted that the fund was well on its way to the 5 year-\$100,000 goal set in its first year. In other business, the Future Fund grant committee presented 3 grant candidates for review. Those in attendance voted to grant \$1,100.00 to the Women's Resource Center to be used for additional parenting curriculum. This grant marked the first gift to the community from the Future Fund. The group will continue to make grants on a yearly basis at its fall business meeting.

Types of Funds

When people want to make a charitable gift, the most common option is to make a donation to a public charity, such as the Community Foundation of Southeast Kansas (CFSEK), that serves a broad range of causes. The CFSEK permits people to tailor their gifts to serve their charitable interests and financial goals now and in the future. A wide range of philanthropic options are offered by the CFSEK. They include:

Donor-Advised Funds are often created as an alternative to a private foundation and allow donors to recommend the charitable organizations and causes to be considered for grants.

Field-of-Interest Funds benefit specific areas such as education, youth, health, the arts, etc. that are of interest to the donor. They can also benefit a geographical area.

Unrestricted Funds give the CFSEK the discretion to make grants that address the most urgent needs of the community as they change over time.

Designated Funds make grants to specific organizations chosen by the donor when the fund is established.

Scholarship Funds Donors may designate a particular school, field of study, select eligibility requirements, and name an advisory committee

Agency Endowment Funds are created by other nonprofit organizations as a means of protecting their charitable dollars for the future and to ensure a source of annual support for their programs and operations.
