### 2010 CFSEK Unrestricted Endowment Fund Grants

The CFSEK Unrestricted Endowment Fund is critical to sustaining the mission of the Foundation to improve the quality of life of Southeast Kansas citizens into the future. Gifts to this fund will provide the necessary flexibility and financial resources to address the changing needs of the Southeast Kansas region including stressors that impact children, families, elderly, animals, arts and culture, and the environment. Grants for 2010 from the Community Foundation of Southeast Kansas Unrestricted Endowment Fund were:

**Catholic Charities**: To support Money Smart, an adult Financial Literacy program that will educate 48 individuals on budgeting, managing credit wisely, and understanding checking accounts

**Class, LTD**: To support the Emergency Assistance for Individuals with Developmental Disabilities Program. This program's goal is that persons with developmental disabilities in Southeast Kansas have the goods and services they need to live safe, healthy, productive lives in their community.

**Elm Acres Foundation:** To fund "Responsible Thoughts and Choices" a program to empower residents (youth ages 12-18) to be responsible for changing their own behavior through a continuum of interventions to address their cognitive, social and emotional needs.

**Pittsburg Community Theatre:** To fund the Junior Starz Children's Drama Workshop for the summer of 2011. The program is open to children ages 6-12 in the Pittsburg and Crawford county area.

**Bourbon County 4-H Council:** To support the ongoing leadership opportunities for youth to become engaged in the 4-H program, develop leadership and citizenship skills and to provide recognition for achievement.

**Family Life Center:** To support the Cherokee County Truancy and Afterschool Program which provides counseling services to youth and families, and afterschool programs for "at risk" youth as identified by the court system.

**Crawford County Restorative Justice:** To be used for the "Little Changes Count" program that will incorporate nutritional education into their On the Right Track Program. This program serves approximately 15 at-risk youth to develop better decision-making skills.

**Children's Advocacy Center:** To support services to abused children in Southeast Kansas. Number of children estimated to be served each year is approximately 100 to 130.

**Labette County Emergency Assistance Center:** To support the program whose specific goals are to prevent hunger, utility disconnection and eviction for low-income households in Labette County. The program hopes to serve additional 30-35 families with CFSEK funds.

**The Hangout:** To fund a strategic planning session with a facilitator as a way to explore the viability of a teen center in the Pittsburg area.

## 2010 Rosalie Manley Endowment Fund Grants

In 2009, the CFSEK received a bequest from the Rosalie Manley estate for the purpose of creating an unrestricted endowment fund with annual allocations from the fund being used for grant making in the region. Inaugural grants for 2010 made in honor of Mrs. Manley were:

**Bourbon County Inter-Agency Coalition:** To support the Network for Families Fund that provides utility assistance for low-income families with children in Bourbon County. The program hopes to serve approximately 50 families throughout 2011.

**Wesley House:** To support the Children's Summer Food Program that provides a sack of food per child per week during the summer, to assist low-income families in Crawford County. Wesley House estimates they will provide 5,000 sacks of food in the summer of 2011.

**Community Health Center of Southeast Kansas:** To support Baby4Baby program that will provide new and "gently used" clothing to underprivileged Crawford and Cherokee County children newborn through age 4. The first year goal of this program is to provide a new box of clothes for the children delivered by doctors at CHC/SEK which is estimated at 150 children.

**Kansas Big Brothers Big Sisters of Labette County:** To be used for six "Match Activities" throughout the year to increase public awareness, recruit volunteers, and to provide social interaction for the participants. This program serves at risk children in Labette County ages 5-17.

**Southeast Kansas Education Service Center:** To be used towards funding BlockFest<sup>™</sup> training and community events that will educate parents and early childhood providers as to the importance of "numeracy"-particularly block play.

## **Giving Circles**

Giving Circles are composed of individuals who pool their time and resources to collectively create positive impact around a common area of interest or social issue. Currently, the CFSEK hosts two giving circles: Future Fund and the Rita J. Bicknell Women's Giving Circle.

### 2010 Future Fund Giving Circle Grants:

**Emergency Prescription Assistance:** A grant to Catholic Charities to provide one-time assistance to uninsured persons, or those not eligible for other coverage programs

**Jobs Wanted:** A grant for a computer, printer and supplies to assist victims at the Crisis Resource Center shelter in seeking employment.

**Rewards and Incentives:** A grant to Elm Acres for gift cards and other small incentives for youth who earn, accomplish or achieve above and beyond expectations and who are recognized with incentives to increase pro-social, positive behaviors.

**Get Fit Youth "Try" athlon:** A grant to Kansas Big Brothers Big Sisters of Crawford County to pay for promotional brochures, advertising and marketing materials.

**Healthy Families:** A grant to Kansas Children's Service League to support their Healthy Families program that works with at risk families of young children with unforeseen expenses.

**Reflecting on Financial Literacy and Self-Sufficiency:** A grant to the Mother to Mother Ministry program to provide materials, childcare, children's workshop and incentives for a financial literacy workshop.

**Prescription Assistance Program:** A grant to the Mt Carmel Foundation for patient support after discharge from Via Christi Hospital for those who do not have a prescription benefit program.

**Winter Sports Program:** A grant to New Hope Special Olympics to assist individuals with intellectual disabilities compete in events like skiing, snowshoeing, basketball and volleyball with peers of their own skill level and ability.

### 2010 Rita J. Bicknell Women's Health Fund Giving Circle Grants:

**Women's Resource Center (Vie Medical Clinic):** Complete Lab Testing Availability program; to insure that cost issues would not prevent clients from receiving available services.

**Pre Med Club Clinic:** To fund a Women's Day that will provide specific women's medical supplies and testing to the current program offered through the clinic.

**Labette Health Foundation:** To support the Osteoporosis Prevention Program by supplying funding towards a bone density scanner to replace the current scanner used by Labette Health.

**Community Health Center of Southeast Kansas:** To fund the Women For Women program that will provide training to women to become doulas. These doulas are non-medical personnel who will then work on a volunteer basis with the underserved population of women at CHC/SEK through their pregnancy, childbirth and post-partum. These women will provide physical and emotional support through all phases.

## **Affiliate: Fort Scott Area Community Foundation**

#### 2010 FSACF General Grants

The FSACF proudly awarded grants to area non-profit organizations. The recipients projects demonstrate dedication to and inspiration for improving the quality of life in the Fort Scott area. The grants were for various amounts, depending on the project, and were selected from many applications received. The following organizations were awarded grants for the following projects:

- Visioning a Healthier Bourbon County: Provide a sprinkling irrigation system for a community garden to be created in spring 2011 on the corner of 9th Street and Horton.
- Fort Scott National Historic Site: Support for recruiting and hosting re-enactors to portray historic individuals at the Fort's Chautauqua during the 2011 Good OI' Days celebration.
- Gordon Parks Center for Culture & Diversity: Fund a performance of a dance company from Lawrence, Kansas during the 2011 Gordon Parks Celebration of Culture and Diversity.
- The Beacon: Provide more fresh produce to low-income families during the entire year.
- Fort Scott Middle School: Defray the costs of performance tickets, books, copies of plays and transportation costs associated with Project A.R.T.
- Mother to Mother Ministry: Provide diapers, wipes and cleaning supplies to single mothers and low-income families, in addition to providing funds for utility assistance.

#### Dr. Pratt and Pauline Irby Fund Grants

The Dr. Pratt and Pauline Irby Fund was created as a result of memorial gifts given to the Fort Scott Area Community Foundation after Dr. Pratt Irby's death in July 2010. Recipients were:

- Lowell Milken Education Center: Assist local teachers and students in producing projects demonstrating patriotism and service of Veterans as "Unsung Heroes."
- Fort Scott Public Library: Sponsor special storyteller or music performances for children in summer 2011.


### Fort Scott Community Gala Makes Endowment Gift

## **Types of Funds**

When people want to make a charitable gift, the most common option is to make a donation to a public charity, such as the Community Foundation of Southeast Kansas (CFSEK), that serves a broad range of causes. The CFSEK permits people to tailor their gifts to serve their charitable interests and financial goals now and in the future. A wide range of philanthropic options are offered by the CFSEK. They include:

**Donor-Advised Funds** are often created as an alternative to a private foundation and allow donors to recommend the charitable organizations and causes to be considered for grants.

**Field-of-Interest Funds** benefit specific areas such as education, youth, health, the arts, etc. that are of interest to the donor. They can also benefit a geographical area.

**Unrestricted Funds** give the CFSEK the discretion to make grants that address the most urgent needs of the community as they change over time.

Designated Funds make grants to specific organizations chosen by the donor when the fund is established.

**Scholarship Funds** Donors may designate a particular school, field of study, select eligibility requirements, and name an advisory committee

**Agency Endowment Funds** are created by other nonprofit organizations as a means of protecting their charitable dollars for the future and to ensure a source of annual support for their programs and operations.
