## Brownback Assists with CFSEK Grant at Family Resource Center

On January 5, 2011 Governor Sam Brownback made a stop at the Family Resource Center in Pittsburg to assist with the Baby 4 Baby project. The Governor, his wife, Mary, and Lt. Governor Jeff Colyer were at the Family Resource Center as part of the Heart of Kansas Project to highlight community service throughout the state. The Baby 4 Baby project is a collaboration between the Community Health Center of Southeast Kansas (CHC-SEK) and the Family

Resource Center. The program is funded by a grant from the CFSEK 2010 general grant cycle.

The Baby 4 Baby process begins at the Family Resource Center where they are accepting, cleaning, sorting and repackaging baby and toddler clothes for families in need. CHC-SEK takes the next steps to identify infants a n d children (newborn-age 4) that

might be in need of some clothing and other essential items. The doctors at CHC-SEK are able to hand out the gift bags at key well child appointments (6 months, 1, 2, 3, and 4 years) when it appears there is a need.

CHC-SEK serves approximately 400 expectant mothers annually and 1,600 children newborn through 4 years of age. Statistics show that about a third of the mothers are teen mothers; nearly half are single and nearly half are uninsured. With the average cost to raise a child being \$250,000 not including college expenses, the need for support of this population is great.

Governor Brownback, his wife Mary and Lt Governor Colyer were able to assemble and distribute the first gift bags from this program to Amber Ihrer (pictured above). The Community Foundation of Southeast Kansas is excited to be able to support such a program. We are equally excited the Governor and his wife were able to participate and experience the great work that is done by Community Health Center of SEK and the Family Resource Center.

### IRA Gifts Extended Through 2011!

Congress has extended through 2011 the legislation which allows donors to make tax-free gifts from their IRA accounts. If you are age 70 1/2 or older and do not need all or part of the distributions from your IRA, you can make tax-free gifts totaling up to \$100,000 in 2011 from your traditional IRA to qualified charities until December 31, 2011. If your spouse has a separate IRA account, you may each make a gift up to \$100,000. While you cannot claim a charitable deduction for IRA gifts, your gift amount will reduce your taxable estate, and you will not be required to pay federal income tax on any amounts you distribute to qualified charities.

#### Qualified charitable distributions:

- Can total up to \$100,000 in each tax year (if your spouse has a separate IRA account, you can each contribute up to \$100,000 per tax year);
- Can be excluded from your gross income for federal income tax purposes, however no charitable deduction is available;
- Are not subject to limitations on your itemized deductions.

## 2011 Brings New Officers and Trustees

The start of the new year means new trustees and officers on the CFSEK Board of Trustees. At our first board meeting, we welcomed three new trustees; Vicki Dennett, Montie Taylor, and Kevin Mitchelson. In addition, our new officers assumed their roles. We appreciate these trustees' commitment to serve the foundation in their new roles.
